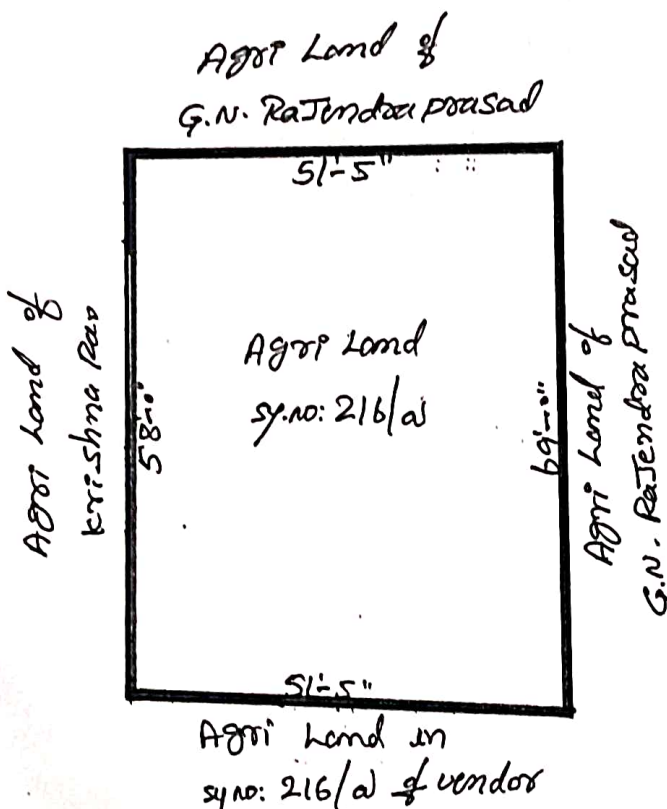


Registration plan showing the AGRI. LAND
