- 5. AND WHEREAS, the SRC in its 388<sup>th</sup> meeting held on 14<sup>th</sup> -15<sup>th</sup> September, 2020 considered the matter and decided as under:-

The original files of the Institution alongwith other related documents, NCTE Act, 1993, Regulations Guidelines issued by NCTE from time to time and documents furnished by the institution were carefully considered by the SRC and the following observations were made:-

On the perusal of the reply submitted by the institution vide letter dt. 10.12.2019, the Committee decided that the continuation order be issued to the Institution Vikas B.Ed College, Ranga Reddy-500030, Telangana for B.Ed programme for 2 basic units (50 students each)






